



SMART METER

« WE DO NOT WANT TOXIC RADIATING ELECTRIC METERS IN OUR HOMES! WE WANT TO MAINTAIN OUR MECHANICAL METERS WHICH ARE HEALTHY, ROBUST, RELIABLE AND HAVE PROVEN THEIR EFFICIENCY »

The decision of the Luxembourgish Government to install a new type of electrical meter, the SMART METER (followed by similar meters for gas and water), is the result of the desire and the unilateral information of a group of economic interest composed by companies and municipalities, a choice made without informing nor having the consent of the public, who is then confronted with an accomplished deal.

A harmless decision apparently... in appearance only, as this is not without consequences on our health and our wallet!

This meter is packed with «performances and techniques» unacceptable for any customer and citizen.

1- The Smart Meter uses your private electrical installation **in your home to inject a constant high frequency signal** (on top of the normal 220V/50Hz electrical current) which is harmful, toxic and carcinogenic for the public health.

This process irradiates a 24 hrs non-stop high frequency signal through your electrical outlets and all your domestic equipment (e.g. refrigerator, washing machine, bedside lamp, all light fixtures) in your home or office work place environment.

To this process, one has also to add the radiation coming through your neighbours through the adjacent walls. You can only be secured by using a shielded wire electrical installation (which no one has).

The inhabitants complain of headaches, imbalance, vomiting, depression, heart irregularities, sleeping disorders, difficulty concentrating, memory loss, nausea, dizziness etc. all over the world where this type of meter has been installed: Canada, USA, Australia ...

All your electronic equipment (switching on/off of a lamp bulb, opening your fridge, getting the laundry done, the time when you watch television, when you get up, go to sleep or even when you are on holidays) is monitored.

5- This technique allows at any moment, night or day, without you being aware, to switch off remotely every and any single household equipment: your boiler, electrical heating, etc... and this with the best intentions in the world!

The consumptions erased remotely via the Smart meter system will not be deducted from your electricity **bill but charged as normal!**

The Smart meter, operating within certain power limits, meant that the short-circuit protection got on so frequently that some subscribers had to pay more in order to increase their power limit.

And as cherry on the cake....after the Smart Meter, they project to also install smart meters for water and gas supply. Hello and welcome to the radiation damages!

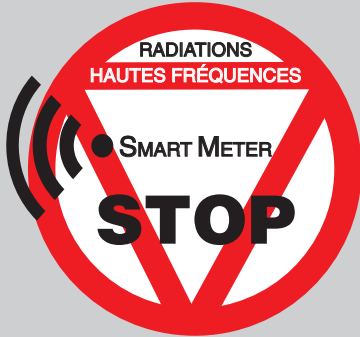
